

Insett qerriedi huwa viċin tagħna

Il-Malta Beekeepers' Association toħroġ direktiva għall-membri tagħha sabiex ħadd ma jimporta naħal miż-żona tal-Italja inkluża Sqallija. Dan għaliex instgħabett mill-ġdid il-ħanfusa ż-żgħira tal-miġbaħ (small hive beetle) ġewwa Sqallija https://www.izsvenezie.com/aethina-tumida-in-italy/?fbclid=IwAR3kqZXwStXnuEZT8bOndvZ1wgznRFTHA9tLRwDG9YZhOdyd7ilpSb_7HTQ. Filwaqt illi nazzjonijiet oħra jaffordjaw illi jikkumbattu din il-ħanfusa billi jeqirdu l-kaxxi tan-naħal, f'Malta din tfisser il-qerda totali tan-naħall lokali.

Għalhekk ma nistgħux nispermettu li din tidħol fi xtutna. Inheġġu wkoll l-entitajiet koncernati fosthom id-Direttorat tal-veterinrarji u regolazzjoni (VRD) u l-Awtorita għal Ambjent u Riżorsi (ERA) sabiex jieħdu deċiżjonijiet għaqlin fejn jidħlu naħal u biex jgħarfu nagħmlu użu tar-riżorsi uniċi tagħna permezz tal-izolament naturali illi joffru il-gżejjer tagħna. Għaldaqstant IMBA tappella biex toħrog ordni nazzjonali li twaqqa kull tip ta' importazzjoni ta' naħal miż-żoni kollha affetwati bl-*Aethina tumida* biex nassiguraw li n-naħal tagħna majkunx affetwat minn dan l-insett.

The destructive insect is near

The Malta Beekeepers' Association issues a directive for its members so that imports from Italy and Sicily areas are stopped at once. This is due to the recent rediscovery of the small hive beetle (SHB) in the neighbouring island of Sicily https://www.izsvenezie.com/aethina-tumida-in-italy/?fbclid=IwAR3kqZXwStXnuEZT8bOndvZ1wgznRFTHA9tLRwDG9YZhOdyd7ilpSb_7HTQ. Whilst other states can eliminate this beetle by mass destruction of beehives, in Malta this means the total destruction of the local honey bees.

Therefore the introduction of such pest on our islands is not to be risked. We encourage the concerned entities especially the Veterinary Regulation Directorate (VRD) and the Environment and Resources Authority (ERA) to take wise decisions where honey bees are concerned and to learn make use of our unique resources with the natural isolation that our islands offer. Therefore the MBA requests that a national order to stop every importation of honeybees from every zone affected with the *Aethina tumida* to ensure that our honeybees will not be affected by this insect.
